We the following TGT/upgraded in Bs-16, education department Skardu, have the honor to invite your kind attention towards the facts and circumstances stated against each:

1. Muhammad Iqbal TGT.

Appointed as teacher BS-9 and upgraded Bs-14 on 1-10-1999 and has been placed at serial No.31 of the seniority list of teachers, on district level while placed at S.No.57 on G,B. Level. All the teachers/TGTs of education Department Skardu have been promoted from BS-14 to BS-16 and then BS-16 to BS-17 except we the three teachers/TGTs due to non inclusion in the seniority list of teachers for misunderstanding or the otherwise, however i with the other two TGTS /teachers have been upgraded from Bs-14 to 16. The case has been referred to the inquiry Committee to investigate the matter and submission of recommendation. The Inquiry Committee instituted for the purpose after thorough examination of the matter reached to the bottom of the case and fully recommended us for promotion from Bs-14 to Bs-16 and Bs\_16 to Bs-17, like all other teachers who have promoted on the scales stated above and the case was forwarded to the Director Education Gilgit who has submitted the case with full bio data and related papers to your good office vide No. <sup>OF</sup> 501/2015 dated 30 May 2016 and the case has been returned to the Director Education with the observation that the case is to be run through Director General Education G.B, and the during the action the question of personal hearing is arise. The Junior TGTs have filed appeal against the order for production in personal hearing, however we the senior TGTS have not included with the junior TGTs and quite ready attend before the authority of personal hearing so that we the illegal targeted TGTs could be able to get our legitimate right.

2. Muhammad Ali Zar TGT

Appointed as teacher and upgraded in Bs-9 on 01-06-1991, and upgraded in Bs-14 on 1-2-2000, and placed at serial NO.35 of the seniority list of District level and 58 of G.B level. while all the circumstances and facts are as mentioned above.

3. Ashiq Hussain TGT

As mentioned in para 2 above who has been placed at S.No.58 of the seniority list with 191 on G.B. Level.

It is therefore humbly requested that the case may kindly be considered favorably and we may kindly be promoted from Bs-14 to Bs-16 and Bs-16 to Bs-17, like other TGTS who already availing the said scales, from Bs-14 to Bs-16 on 14-12-2009 and Bs-16 to Bs-17 from 21-9-2015, as the same is our legitimate right.
