- a) That the alleged content in Program "Inside The News" on 15<sup>th</sup> July 2020 hosted by Ms. Alveena Agha on Metro1 News regarding Schon Group was aired Live in the program without any involvement of Management or Organization solely by the Host of the Program.
- b) That the alleged content was not even in the topic of the program neither it was on the liners of the program.
- c) That we already issued Ms. Alveena Agha, host of the program, Show Cause Notice regarding the matter and Suspended her for a week as a punishment for including the content without consent and approval of the management.
- d) That we have also aired the apology in the same program by the Host on 10<sup>th</sup> September 2020. (Video Clip Attached.)

e) We further assure that no further incident of this nature happen again on future and we apologize for any inconvenience caused to Schon Group. That in view of the above, we hope that the complainant will overlook the matter and the complaint will be withdrawn as a human error.
