Sir,

This is to inform that M/s Royal Travel Services cheque of Rs. 6,818,212 /- for the sale report 1-15 Jan 2020 has bounced again (Scanned copy attached). Subsequently an amount of PKR 2,607,000 was received from agent while the remaining amount is still outstanding. This is seventh instance that agent has been unable to pay the due amount on time.

Following are the instances on which agent was unable to meet his obligations on time.

- 1. 2nd Fortnight of April 2019
- 2. 1st Fortnight of July 2019
- 3. 2nd Fortnight of July 2019
- 4. 1st Fortnight of August 2019
- 5. 1st Fortnight of December 2019
- 6. 2nd Fortnight of December 2019
- 7. 1st Fortnight of January 2020

According to financial circular - 01-2017

PSA Agreement Article 3D states;

"In case of overdue sale transmittal, Incomplete sale transmittal, late reported transactions, unreported transaction, overdue remittance or cheque, a warning letter will be issued to agent. In case of repeated irregularities, Principle reserves the right to either demand subsequent payment through pay orders or immediately terminate the agreement".

AND

"Six (6) repeated irregularities during a year, Principle reserves the right to terminate the PSA Agreement.

It is recommended that immediate corrective measures be taken for recovery of outstanding amounts and mitigate PK financial exposure.
